Sue Bell Cobb to Speak at LWVM's First Monthly Luncheon

LWV-Mobile will launch its fall study, *Money in Elections*, with retired Alabama Supreme Court Chief Justice Sue Bell Cobb, an advocate on the state and national levels for judicial selection reform. Cobb knows the topic well. She won election to the state's highest court in the most expensive judicial campaign in the nation that year -- with \$2.6 million in her campaign coffers and nearly twice that amount, \$5 million, in her opponent's coffers.

At our September 16 luncheon, Alabama's first female chief justice will offer perspective for voters as the state readies itself to elect three of the court's nine justices in 2016. Alabama led the nation in campaign spending for its supreme court races until recently. It is one of 39 states that elects its judges.

Cobb is a strong advocate for appointed judgeships. After serving as a judge for 25 years, she won election as chief justice on the Alabama Supreme Court in 2006. She retired in 2011.

"Those of us seeking judicial office often find ourselves doing things that feel awfully unsavory." Cobb wrote recently in Politico Magazine. "When a judge asks a lawyer who appears in his or her court for a campaign check, it's about as close as you can get to legalized extortion."

Cobb writes in Politico about her discomfort asking friends and acquaintances in the legal profession for campaign contributions and describes perfectly legal, but "shameful" and "embarrassing," tactics used by some successful judicial candidates around the country.

Our campaign finance study is part of a nationwide League of Women Voters examination of the issue, which will hopefully lead to the formation of an updated national position on campaign finance.

Vogel, Kenneth P., 2014: Big Money

November 9

Barbara Caddell and Gina Finnegan will summarize and lead discussion on the book "The New Soft Money" by Daniel Tokaji and Renata Strause. (Google "The New Soft Money.")

December 14

We will hold our consensus meeting. This format is used locally and on state and national levels to develop positions on issues. With consensus, we will update our position. If we do not reach consensus on certain questions, we will not adopt those as part of our recommendations to the national position.

Member Profile - Linda Langan



Linda Langan joined the League of Women Voters of Mobile this year. She became aware of the LWVM after a visit with her aunt who lives in Panama City, Florida. While staying with her aunt she was invited to attend a LWV Panama City meeting. She was impressed by the discussions among this group of LWV members and for their concerns and actions on behalf of their community. Upon arriving back home in Mobile, she looked online and discovered the LWV of Mobile. Delighted to find an active LWV in Mobile, she immediately contacted Beth Hardaway, became a member and attended the next monthly study group meeting. Since that time she has become an active LWVM member and serves on two of the LWVM committees, as well as becoming a LWVM board member.

Linda is a fairly recent retiree after having a 40 year career in nursing. Born in Liverpool, England, to an American father serving in the Air Force overseas and a British mother, Linda grew up with her two brothers in both the United States and in England. As an operating room nurse she worked on many different surgical teams specializing in neurosurgical, plastic and reconstructive, as well as other specialty surgical procedures. She also held other positions in nursing management, in the specialty of reproductive endocrinology and she served in the position as a patient educator. She became a Women's Health Nurse Practitioner in 1983 and was one of the first board certified nurse practitioners within the city of Mobile. Linda practiced as a nurse practitioner at Mobile County Health Department and Jefferson County (Birmingham) Health Department during her career.

She attended Spring Hill College and graduated Magna Cum Laude. She has two children, both of who are grown and married. Her son is employed by Deloitte, and he and his family live in Orlando, Florida. Her daughter, a former Fulbright Scholar, is a practicing certified critical care and cardiac RN at Children's National Hospital in Washington D C, and lives with her family in Silver Spring, Maryland. Linda has 4 grandchildren and is excited about the anticipated arrival of a new grandson at the end of September. Linda travels quite frequently to spend time with her grandchildren and she declares that being a grandmother is the best job she has ever had!

Linda is married to Dr. David Langan, Professor Emeritus, who taught at the School of Computing at the University of South Alabama for 30 years. Together they enjoy traveling and last year spent four months traveling to England, France and Spain. They recently returned from the west coast after an Alaskan cruise and spending time with family and friends in Seattle and San Diego. Linda's other interests include reading, oil and acrylic painting, swimming and working on interior decorating projects.
